

**SPORTS FAN BUCKET LIST GIVEAWAY
OFFICIAL RULES**

NO PURCHASE NECESSARY TO ENTER OR WIN. MAKING A PURCHASE WILL NOT IMPROVE YOUR CHANCES OF WINNING.

ALL DISPUTES WILL BE RESOLVED SOLELY BY BINDING ARBITRATION AND ENTRANTS WAIVE THE ABILITY TO BRING CLAIMS IN A CLASS ACTION FORMAT.

SWEEPSTAKES ENTRY PERIOD: The Sports Fan Bucket List Giveaway (The "Sweepstakes") begins at 12:00:00 AM Eastern Time ("ET") on December 18, 2022 and ends at 11:59:59 PM ET on January 23, 2023 (the "Sweepstakes Period"). The Sponsor's computer is the official timekeeping device for this Sweepstakes.

The make and model of the TV is at Sponsor's sole discretion. Any difference between the stated ARV of the Second Prize and actual cost at time of purchase will not be awarded.

Total ARV of all prizes: \$24,797. Limit one (1) prize per person/household.

Odds of winning a prize will depend upon the total number of eligible entries received.

RANDOM DRAWING: One (1) Grand Prize winner, one (1) First Prize winner, and three (3) Second Prize winners will be randomly selected in a drawing conducted on or about January 24, 2023, by an independent judging agency appointed by the Sponsor, whose decisions are final.

WINNER NOTIFICATIONS AND VERIFICATIONS: A representative of the Sponsor will make up to five (5) attempts within a 24-hour period to reach potential Grand and First Prize winners by phone at the phone number provided at the time of entry and potential winner must verbally confirm their intention to claim the prize at that time (“Initial Notification”). DISPUTES: The parties hereto each agree to finally settle all disputes only through arbitration; provided, however, the Released Parties shall be entitled to seek injunctive or equitable relief in the state and federal courts in Carroll County, MD, and any other court with jurisdiction over the parties. In arbitration, there is no judge or jury and review is limited. The arbitrator's decision and award are final and binding, with limited exceptions, and judgment on the award may be entered in any court with jurisdiction.
